

His supervisor discussed with him the importance of professional boundaries and respectful treatment of residents. The staff member was asked not to "hang out" with residents. He will be given an extra three hours of training in regards to resident rights and professional boundaries before he is taken off probation.</p> <p>Long-term: Staff member A's supervisor will verify that he has received the three hours of additional training and been compliant with maintaining resident rights before removing him from his probationary status.
