The Department of Public Welfare conducted an annual Licensing inspection of this provider on May 30, 2012 for the licensing year extending from July 19, 2011 to July 19, 2012. During the inspection, Departmental staff reviewed 11 of 11 approved foster homes, 2 of 4 foster child files and 9 staff files, including 4 new hires.

CHOR Youth and Family Services, Inc provide Multidimensional Treatment Foster Care (MTFC) to children in Cumberland and Dauphin Counties. The MTFC Program provides placement in a family setting to avoid more restrictive placements. The treatment foster families have been extensively trained to provide structure, guidance and services to help youth and their family during placement with CHOR. The program is intended for youth experiencing emotional and behavioral challenges. The program utilizes a Treatment Team approach in an attempt to decrease challenging behaviors and to increase developmentally appropriate social skills and behaviors, and to help youth experience success at home, at school, and in the community.

The agency has not written any Child Profiles or Adoptive Family Profiles since the opening of the program in May 2010.
