1. REGULATION 55 Pa.Code §2600

2600.103(e) - Food served and returned from an individual's plate may not be served again or used in the preparation of other dishes. Leftover food shall be labeled and dated.

2a. DESCRIPTION OF VIOLATION

The refrigerator in the kitchen had a bag of grated parmesan cheese and a package of smoked turkey breast lunch meat that was not labeled or dated.

Include steps to correct the violation described above and steps to prevent a similar violation from occurring again. If steps cannot be completed immediately, include dates by which the steps will be completed.

Regulation 55 Pa. code 2600.103 (e) was violated because the refrigerator in the kitchen had a bag of parmesan cheese and a package of smoked turkey breast lunch meat that was not labled or dated. This regulation is important in order to prevent re-serving outdated food. This regulation will be in compliance immediately by labeling the food with an experation date as well as the date it was opened. This practice has been implimented and will continue to be monitored as a daily routine by the administrator. •
