**1. REGULATION 55 Pa.Code §2600**  
 2600.132(g) - Fire drills shall be held on different days of the week, at different times of the day and night, not routinely held when additional staff persons are present and not routinely held at times when resident attendance is low.

**2a. DESCRIPTION OF VIOLATION**  
 The fire drill conducted on 1-29-16 indicated that 5 staff persons participated in the fire drill. There were only 4 staff persons on the schedule and a visitor who participated in the drill and was counted as a staff person. It was determined that the visitor was the VP/COO of the legal entity who assisted with the fire drill on this day.  
 The monthly fire drills conducted from 11-30-15 to 3-28-16 were all completed in the last three days of the month.
