Acadia has implemented this for all its residences, the drills have also started January of 2018.

The administrator shall review the fire drill log monthly to assure that a successful drill has been completed and assure the frequency of sleeping hours fire drills are held in compliance with the regulatory timeframes. *BAS 2/8/18*


