Upon further review, it was determined that Mt. Trexler Manor notified the North East Region of the Bureau of Human Services Licensing on November 30, 2017 stating that they were in compliance with the violations specified on the licensing inspection summary from licensing inspections on May 31, 2017, June 1, 2017, and August 17, 2017.

As such, the Department hereby rescinds the sections of the Department's fine assessment letter dated December 11, 2017 and corresponding invoices dated December 11, 2017 and January 24, 2018 pertaining to §2600.187(a), §2600.187(c) and §2600.187(d).

Pursuant to 62 P.S. §§ 1085-1087 and 55 Pa.Code §§ 2600.261-268 (relating to enforcement), the Department hereby assesses a fine for the uncorrected violation of §2600.187(a), §2600.187(c) and §2600.187(d) from October 24, 2017 through November 30, 2017, the day the fines listed above stopped accruing.
