On August 15, 2018, the Personal Care Home license #226930 was issued for the period of August 15, 2018 to August 31, 2018 to Country Meadows of Allentown LLC to operate Country Meadows of Allentown at 430 North Krocks Road, Allentown, Pennsylvania. In accordance with your application dated July 19, 2018, the new Certificate of Compliance was a consolidation of Personal Care Home licenses #226930 and #226940 (Country Meadows of Allentown Building 1 and Country Meadows of Allentown Building 2, respectively) into one single Certificate of Compliance.

The single Certificate of Compliance was issued in error. A review of the personal care homes shows that they are operating independently of one another with respect to kitchen and food preparation services, activity services and community recreation space, staffing, medication administration and management, and individual building certificate of occupancy. Therefore, the Certificate of Compliance issued on August 15, 2018 is being rescinded and the previous Certificates of Compliance with their separate capacities are being reinstated. The expiration dates of the Certificates of Compliance remain unchanged. Your reinstated Certificates of Compliance are enclosed. Since the previously issued Certificates of Compliance are no longer valid, you may return them to the Bureau of Human Services Licensing regional office or take steps to shred the documents.
