

Dear Ms. Ponterio:

On August 16, 2018, the Personal Care Home license #219300 was issued for the period of August 16, 2018 to November 16, 2018 to Country Meadows of Northampton Associates LLC to operate Country Meadows of Bethlehem at 4011 Green Pond Road, Bethlehem, Pennsylvania. In accordance with your application dated July 19, 2018, the new Certificate of Compliance was a consolidation of Personal Care Home licenses #237880, #200750, #232880, and #219300 (Meadows Living Center at Country Meadows of Bethlehem, Country Meadows of Bethlehem V, Country Meadows of Bethlehem III, and Country Meadows of Bethlehem, respectively) into one single Certificate of Compliance.

The single Certificate of Compliance was issued in error. A review of the personal care homes shows that they are operating independently of one another with respect to kitchen and food preparation services, activity services and community recreation space, staffing, medication administration and management, and individual building certificate of occupancy. Therefore, the Certificate of Compliance issued on August 16, 2018 is being rescinded and the previous Certificates of Compliance with their separate capacities are being reinstated. The expiration dates of the Certificates of Compliance remain unchanged. Your reinstated Certificates of Compliance are enclosed. Since the previously issued Certificates of Compliance are no longer valid, you may return them to the Bureau of Human Services Licensing regional office or take steps to shred the documents.
