On July 31, 2018, the Personal Care Home license #310210 was issued for the period of July 31, 2018 to July 4, 2019 to The Ecumenical Community to operate Ecumenical Retirement Community at 3525 Canby Street, Harrisburg, Pennsylvania. In accordance with your application dated July 19, 2018, the new Certificate of Compliance was a consolidation of Personal Care Home licenses #362150, #353610, and #310210, (Ecumenical Retirement Community of Harrisburg II, Ecumenical Community of Harrisburg, and Ecumenical Retirement Community of Harrisburg III, respectively) into one single Certificate of Compliance.

The single Certificate of Compliance was issued in error. A review of the personal care homes shows that they are operating independently of one another with respect to kitchen and food preparation services, activity services and community recreation space, staffing, medication administration and management, and individual building certificate of occupancy. Therefore, the Certificate of Compliance issued on July 31, 2018 is being rescinded and the previous Certificates of Compliance with their separate capacities are being reinstated. The expiration dates of the Certificates of Compliance remain unchanged. Your reinstated Certificates of Compliance are enclosed. Since the previously issued Certificates of Compliance are no longer valid, you may return them to the Bureau of Human Services Licensing regional office or take steps to shred the documents.
