As a result of the Department's Bureau of Human Services Licensing annual inspection on December 4, 2018, we have found the above facility to be in compliance with 55 Pa. Code Ch. 2600 (relating to Personal Care Homes).

As the result of your home's recent request to adjust the use of the physical space, the Department has granted an approval for a revised license issued under the authority of 55 Pa. Code Ch. 2600 (relating to Personal Care Homes). The approved capacity revision request is an addition of 22 SDCU, the number of personal care is now reduced to 44. The expiration date of the license remains unchanged.
