2600.

## Description of Violation

5. Poster will be emailed weekly to staff in the "email 4 all" system internally at Providence Point.

6. Staff Member [REDACTED] was counseled by Administrator on 2-4-21 regarding putting a report of abuse in note form under Administrator's door. [REDACTED] was reminded of the recent education [REDACTED] signed off on that educated [REDACTED] on how and when to report abuse. Responsible Party: Administrator.

7. Staff will be disciplined using corrective action up to and including termination for failure to report abuse immediately. This is noted on the Posters. Responsible Party: Administrator.

8. Administrator will report abuse immediately upon receipt of any allegation of abuse. Responsible Party: Administrator.
