Resident #1's most recent support plan, dated 6/3/2020, indicates, "Staff to assist resident #1 with transfers and slide board." However, on 4/9/21 at approximately 7 a.m., resident #1 indicated [redacted] transferred [redacted] from [redacted] bed to [redacted] wheelchair using the slide board without the assistance of a direct care staff person.
