1. Requirements

2600.

42.b. A resident may not be neglected, intimidated, physically or verbally abused, mistreated, subjected to corporal punishment or disciplined in any way.

Description of Violation

On 10/27/21 at approximately 5:30am, staff member A heard screaming coming from resident #1's bedroom. When staff member A entered the room, staff member B was observed holding one of resident #1's leg and arm and said, "Do not scream at me! I am sick and tired of people resisting my care when I'm just trying to help them."

Plan of Correction**Accept**

On December 29, 2021 all associates were educated on abuse and neglect by [REDACTED], Executive Director. See attachment for sign in sheet along with materials that were covered.

Resident abuse and reporting abuse including dignity and respect will be reviewed at our next 3 associate meetings (January 19th, February 16th and March 16) by Executive Director to ensure that all associates know what to do if this is witnessed in the future.

Documentation of staff educations will be kept in a binder in the Executive Directors office. This will include the training on December 29th at the all associate meeting.

Executive Director or Designee will interview 3 residents monthly for the next 3 months to ensure that residents are being treated with dignity and respect and are not being subjected to abuse. Resident interviews will take place on January 11th, February 8th and March 8th at our townhall meeting. Please see attachment for audit.

Staff person "B" was terminated from Artis Senior Living. Termination letter was mailed on 1/6/2022. The associate has not worked at the community since 10/27/2021.
