42b - Abuse

1. Requirements

2600.

42.b. A resident may not be neglected, intimidated, physically or verbally abused, mistreated, subjected to corporal punishment or disciplined in any way.

Description of Violation

Staff person A entered resident 1's bedroom, they showed them pornographic pictures on their cell phone, they then proceeded to pull out their [REDACTED] and masturbate while fondling resident 1 [REDACTED]. Resident 1 told them to stop, and staff person A did not stop and they continued until they sexually relieved themselves.

POC Submission**Accept (MJ - 09/06/2022)**

Immediately on 8/10/2022 when the resident reported this Abuse, to the Lead staff and Personal Care Home Administrator action steps were implemented.

The Pennsylvania Department of Human Services incident Report was completed and send to on [REDACTED] Mandatory Abuse Report was completed on [REDACTED] and send to The Pennsylvania Department of Aging. An investigation was conducted by Adult and Aging, Department Human Services and we have an in-house investigation by our Agency investigator as well.

[REDACTED] Agency staff haven't work on site sent January 8,2022.

Moving forward we will review and ensure that all outside Agency staff are properly trained. We will also, encourage all residents to come to staff or the PCH Administrator, if they feel that they are Abuse in anyway. We will talk about Abuse in the resident Co-op meeting to ensure that the resident feel comfortable talking about any issues that they might have experience. Staff will encourage them to not wait to report any signs of abuse.
