Description of Violation

On [REDACTED] staff person "A" made a verbal comment toward resident #1 which was overheard by staff person "B." The comment made by staff person "A" was "want me to wipe your ass for you too." It was also reported by staff person "B" on [REDACTED] he/she heard staff person "A" make a rude remark on [REDACTED] toward resident #2 who had thrown up on his/her shirt. The comment made by staff person "A" toward resident #2 was "whatever, then stay in your clothes covered with freaking puke." " If you want to stay in that shit then so be it." Staff person "A" did not treat residents #1 and #2 with dignity and respect. Staff person was suspended on [REDACTED] and terminated effective [REDACTED]

Plan of Correction

Staff Person A is no longer working with this organization. The Program Supervisors will review resident rights and reporting requirements with all staff members at the monthly staff meeting on 11/17/2022. Resident's Rights and Adult Protective service/Older Adult Protective Services is reviewed annually by all staff. Program Supervisors are responsible for ensuring that staff complete this training.
