2. Requirements

2600.

15.b. If there is an allegation of abuse of a resident involving a home's staff person, the home shall immediately develop and implement a plan of supervision or suspend the staff person involved in the alleged incident.

Description of Violation

On [REDACTED]/23, the home was notified of an allegation of abuse by the Office of Senior Services. The allegation was that staff member A, staff member B, and staff member C were abusing and recording resident 1. The home did not immediately develop and implement a plan of supervision or suspend the staff members involved in the alleged incident.

Repeated Violations- 6/22/22 et al

Plan of Correction

Accept ([REDACTED] - 05/24/2023)

The Executive Director was made aware of the allegation by Protective Services. The Executive Director immediately, along with protective services, investigated the accusation and it was determined to be unfounded. Due to this, no staff was suspended and no supervision plan was put into place. Moving forward, the Executive Director or Director of Health and Wellness will immediately suspend any staff member accused of abuse while an investigation is done. If the investigation shows the accusation is false or unfounded by the community, protective services, or DHS investigation, the staff member will be return to full duty. The Executive Director will train the Director of Health and Wellness on this process by 5/24/2023.

Plan of Correction

The Executive Director or Director of Health and Wellness will immediately notify the family of any accusation of abuse against their loved one. The Executive Director or Director of Health and Wellness will make a note of the notification on the reportable incident provided to DHS and in the residents progress notes. The Executive Director will train the Director of Health and Wellness on this process by 5/24/2023. A copy of the reportable incident will be maintained by the Executive Director for DHS review.
