An investigation was completed in reference to the allegations of dignity and respect. Resident 1 was not a reliable witness due to the various renditions of her account of the incident. Although the exact allegation from staff member A could not be exactly confirmed, New Vitae separated with staff member B after final investigation. All AR staff were retained on 4/19/2023 on Residents' Rights/Abuse and Neglect.
