1. Requirements

2600.

42.b. A resident may not be neglected, intimidated, physically or verbally abused, mistreated, subjected to corporal punishment or disciplined in any way.

Description of Violation

On [REDACTED] during a session with their therapist resident #1 reported being sexually assaulted by resident #2 and reported that they didn't feel safe in the home because of it. On [REDACTED] during a session with their therapist resident #3 reported having been coerced into sexual interactions with resident #2. It was determined that residents #1 and #3 were sexually harassed by resident #2.

Plan of Correction

Accept ([REDACTED] - 08/03/2023)

During the investigation, Resident #2 indicated they believed [REDACTED] was engaging in a relationship with both individuals. Additionally, both Resident #1 and Resident #3 indicated they engaged resident #2 during interactions but felt pressured at times.

To prevent recurrence, Mount Trexler Manor has changed their house rules to include a rule about reporting concerning interactions with staff or peers in the home. Additionally, all residents were provided a 30-day notice of this additional rule. All residents were asked to sign the 30-day notice statement indicating they were informed of the new house rule. Residents were addressed during their July House meeting regarding the appropriate interactions with others and how to report concerns.

The administrator will ensure compliance.
