Resident #1 was transferred from memory care (secured care dementia unit) to senior care on [redacted]/23. A resident assessment and support plan (RASP) for the resident's significant change was completed on [redacted]/23. However, the personal care need for supervision and mental health need of wandering were not updated on the RASP.

Resident #2 was observed having documentation dated [redacted]/23, written by the homes CRNP, to initiate hospice services. Hospice services began on [redacted]/23. However, the most recent RASP for resident #2 was the initial RASP dated [redacted]/23. No additional RASP was created for the significant change to initiate hospice services.
