Description of Violation

Resident [redacted]'s most recent assessment and support plan completed on [redacted] and [redacted], indicated a need of supervision as "requires minimal supervision in the home and needs attendance when outside the home in unfamiliar surroundings with a plan to meet this assessed need of hourly checks during waking hours hourly checks during sleeping hours and 15-minute check when in the community. However, on [redacted] Resident [redacted] did not receive this service when [redacted] was unaccompanied by staff and in the community for approximately 1 hour and 15 minutes.

The programs Residential Supervisor will conduct weekly spot checks of supervision x 4 weeks beginning the week of July 27, 2025.
