1. Requirements

85.b. There may be no evidence of infestation of insects or rodents in the home.

Description of Violation

At approximately 11:15 a.m., an agent of the Department observed live bed bugs on 2 residents' sheets and mattresses in bedroom #2. Multiple live bed bugs were crawling out of the corner crevice of one mattress and a live bed bug and multiple red and brownish blood smears on the orange fitted sheet throughout the mattress of another resident mattress in bedroom #2.

Plan of Correction

Staff immediately changed all the sheets and wiped down all the furniture and floors. Staff swept and mopped and washed all linens. Staff will continue changing all bed linens every morning. The home will continue to have rooms steam cleaned by maintenance and owner. PMSI pest control continues to come monthly to spray the home and educate staff. Staff education will take place Tuesday July 29th. Proof of education, bills, and record of steam cleanings will be submitted.
