Description of Violation

On [redacted] resident [redacted] became upset with another resident and "swatted" the resident when the resident asked [redacted] several times to move out of the doorway. On [redacted] resident [redacted] was in the hallway arguing with another resident. Resident [redacted] open handedly smacked the other resident about the shoulder/chest area. When staff attempted to intervene, resident [redacted] attempted to smack staff. Resident [redacted] assessment, dated [redacted] did not accurately assess the resident's level of agitation and aggression, but indicates the resident has no problem in these areas.

Plan of Correction

Accept [redacted] 10/24/2025)

- The Support Plan for Resident [redacted] was updated on 10/16/2025 by the Director of Health and Wellness to address the resident's aggression and agitation. (Exhibit A)
- The Director of Health and Wellness was educated on regulation 2600.225c on 10/01/2025 by the Executive Director. (Exhibit B)
- The Director of Health and Wellness and or designee will audit 5 support plans weekly for 4 weeks, then 3 support plans weekly for 4 weeks and then 1 support plan weekly for 4 weeks to ensure continued compliance with regulation 2600.225c. The findings of these audits will be discussed monthly at the QA Meeting. The QA Committee will determine if continued auditing is necessary based on 3 months of compliance.
