2600.

The home manages finances for resident [REDACTED]. On [REDACTED] at approximately 12:30 AM, staff person A entered the administrator's office, accessed the key for a filing cabinet, unlocked the filing cabinet, and took [REDACTED] belonging to resident [REDACTED].

Plan of Correction

Accept (SQ - 11/10/2025)

Administrator ([REDACTED]) removed money from filing cabinet and placed in safe with lock combination on 9/7/2025. Administrator ([REDACTED]) and Assistant Administrator ([REDACTED]) are the only two that have combination. On 9/7/2025 a monthly audit with the administrator ([REDACTED]) will compare the balance on the resident's record of financial transactions to the amount of cash on hand, to ensure they match, for each resident for whom the home holds funds or provides financial management. Documentation will be kept. The home did not refund residents funds.
