1. Requirements

2600.

102.k. Use of a common towel is prohibited.

Description of Violation

At approximately 9:23 a.m. there was an unlabeled white hand towel hanging next to the sink in the shared bathroom located near the television room.

Plan of Correction

Accept [REDACTED] - 12/18/2025)

The unlabeled towel was removed immediately (while inspectors were still on site) from the shared bathroom near the television room. This bathroom is shared by the residents in bedroom #3 and #4 . At the time of inspection bedroom #3 was empty, awaiting a resident admission. When a new resident is admitted to bedroom #3, towels will be hung and labeled in the shared bathroom accordingly. Until that admission occurs, no towels will be hung at bedroom #3's designated area. A staff training was held to educate/remind the staff on regulation 2600.102.k (attachmentx 1-5). Staff have also been instructed to continue checking all facility bathrooms every 2 hours as assigned on the facility's daily shift cleaning logs. Paper towels were, and continue to be available in all resident shared bathrooms.
