1. All nurses and med techs who pass medication will be re-educated on documenting the date and time of medication administration at the time of administration, and to include their name and initials in the documentation, as stated in PA Code 2600.187b. Re-education of all staff will be completed by the Resident Care Director, or designee, before April 1, 2026. Documentation of completion of the education will be maintained at Paramount at Bethel Park.

2. Resident Care Manager, or designee, will review the prior day's MAR for all residents to ensure documentation occurs as required by nurses and med techs. Review will occur daily Monday through Friday for 1 month, then three times a week for 1 month, then weekly for 1 month. Saturday and Sunday will be reviewed along with Friday during Monday's review. MAR review start date is March 9, 2026.

3. Licensing Inspection Summary and Plan of Correction will be reviewed during the next quarterly Quality Management Meeting, scheduled on March 31, 2026 (DIRECTED: Documentation of the quality management review shall be kept. [REDACTED] 3/19/26).
