1. Requirements

2600.

42.b. A resident may not be neglected, intimidated, physically or verbally abused, mistreated, subjected to corporal punishment or disciplined in any way.

Description of Violation

On [redacted] Secured Dementia Care Unit (SDCU) residents were taken out of the SDCU to the first floor for a birthday party. At approximately 3:15p.m when residents were being returned to the SDCU., Resident [redacted] was unable to be located. Resident [redacted] was found outside approximately 1 block from the facility at 3:45p.m. Resident [redacted] has a history of exit seeking including a previous elopement from the facility.

Plan of Correction

Accept [redacted] - 04/09/2026)

Upon Residents [redacted]'s escorted return to the facility, a full body audit was completed. No injury was noted upon assessment. Emotional support was provided to the resident by staff on duty. Resident [redacted] was placed on 30-minute checks until 2/23/26. No exit-seeking behaviors were noted during this time.

All DCS who work in the homes SDCU were verbally educated by the Administrator on the importance of headcounts before leaving the SDCU, during the scheduled activity, and upon return to the SDCU from the activity.

If Resident #1 chooses to participate in an activity outside the homes SDCU, a designated staff member will stay in close proximity of Resident #1 to ensure safety.

234.b. The support plan must identify the resident's physical, medical, social, cognitive and safety needs.

Description of Violation

The Resident Assessment and Support Plan for Resident [redacted] dated [redacted], indicates that the resident requires supervision for outings when outside of the SDCU. On [redacted], Resident [redacted] was taken outside of the SDCU for a party and was able to elope from the facility.

Plan of Correction

Accept [redacted] - 04/09/2026)

If Resident [redacted] chooses to participate in an activity outside the homes SDCU, a designated staff member will stay in close proximity of Resident [redacted] to ensure safety.

Resident #1's RASP was reviewed and revised on 2/23/26 to clearly emphasize the resident's high elopement risk and reinforce the requirement for direct supervision at all times when out of the SDCU.

**234b Support Plan Needs Elements (continued)**

Assistant Administer will review Resident [REDACTED]'s updated RASP with all SDCU DCS.

All DCS will be trained by the Administrator on recognizing and responding to exit seeking behaviors by 4/27/26 and yearly thereafter.

Assistant Administrator will conduct weekly audits of resident support plans for completeness and accuracy.

Assistant Administrator will also perform random observations during activities to ensure supervision levels are followed.

Findings will be reviewed as part of the quarterly QA.

Additional staff re training or disciplinary action will occur if non compliance is identified.
