1. Requirements

2600.

42.x. A resident has the right to a system to safeguard a resident's money and property.

Description of Violation

The home manages money for resident [REDACTED] and resident [REDACTED]. The home safeguards resident funds in the case managers office. The home's 'Management of an Individual's Funds' policy indicates, "The Program Director (or next level independent reviewer) is responsible for reviewing and reconciling financial transaction records on a monthly basis. A local operations manager is responsible for monitoring procedures for accuracy and compliance." Staff person A, a case manager, indicated the financial reconciliation of resident accounts is supposed to be done every month; however, it was not performed for 3 months.

On [REDACTED] staff of the home found that resident [REDACTED] is missing [REDACTED] and resident [REDACTED] is missing [REDACTED] in Walmart gift cards. The home failed to safeguard the resident's funds.

Plan of Correction**Accept ([REDACTED] - 07/29/2026)**

The week of 7/6/26, the program implemented weekly audits of all funds with the Case Manager and Program Director for six weeks. The first weekly audit was completed 7/10/26.

The policy was updated by the Quality Improvement Manager on 7/13/26 for approval; this will be finalized by 7/24/26. Once finalized, the program will be educated on the updates. Education will be provided by the Program Director and will be completed by 7/31/26.

Pending no issues with the initial six week audit, the program will move to on-going monthly reviews of the finances. These will be completed by the Program Director or designee, with the Case Manager. Documentation will be kept.
