In response to the violation on [REDACTED] by the Pennsylvania Bureau of Human Service Licensing, immediate action was taken on 07/24/2026 by the Administrator to As of today, and due to Terminix's recent treatment there is 0 signs of activity.

To enhance the currently compliant operations, on 07/24/2026 the Administrator will Keep checking and actively seeking activity re-surfacing and eliminate immediately with treatment by Terminix, with a completion date of 07/24/2026.

Effective 07/24/2026 the Administrator will perform daily checks of actively check, through 08/24/2026 to maintain ongoing compliance with ensuring there is no evidence of infestation of insects or rodents in the home. Any deficiencies will be corrected immediately, and findings will be documented and reviewed internally for continuous improvement purposes.
